All Arts & Crafts items must be homemade and handmade or home grown. The Festival Committee will evaluate each application and reserves the right to deny space for the display or sale of individual items which are not of suitable quality to be displayed in a family environment.

Other vendor areas in the event may be able to accept products and services that do not fall within the purview of Arts & Crafts. Contact Susan Crespino at (417) 626-7363 for more information.

No items may be made from elephant or whale ivory.

The completed application must be accompanied by a personal or company check, credit card information for the fee AND at least two (2) different photos of a grouping of products being exhibited and one (1) of the display booth completely set up.

**EXHIBITOR FEES ARE NON-REFUNDABLE.**

Exhibitors may choose to provide their own tent. A 10' by 10' tent is available from Boomtown Days for an additional \$100. Your request must accompany your application.

Electricity is provided (110v, 15 amp service only). Exhibitors must provide extension cord(s). Additional electrical outlets or a dedicated circuit for equipment that needs more power is available for additional fees. Your request must accompany your application. Security, general lighting and a hospitality area are provided for exhibitors and vendors.

Applicants not accepted will receive a full refund.

Exhibitor is responsible for tables, background materials and any other materials used to make an attractive booth display. All displays must be neat and clean and maintained throughout the duration of the Festival.

Set up will begin at 10 am, Friday, June 6 and must be completed by 3 pm on June 6, at which time the Festival Committee will do a final walk-through. Spaces not occupied by 3 pm

will result in forfeiture of the booth space and all fees. No refund will be granted.

All vehicles/trailers MUST be removed from the booth area, immediately after unloading, PRIOR to display set up. Parking will be provided for your vehicles.

Exhibitors must be present and set up during ALL hours of the event, listed above.

Exhibitors may not sublet or apportion space to anyone else.

Exhibitors shall be liable for delivery, handling, set up and removal of their own displays and materials. The Festival is not responsible for any items left past June 7 at 10 pm.

The Festival Committee may require the removal of work considered in violation of these conditions and reserves the right to make final interpretation of all conditions.

The Festival Committee does not allow any vendor to sell, distribute or giveaway T-shirts, literature, water or beverages of any kind. Some vending, sampling or product/service promotion categories and activities are prohibited, including tobacco, vacation/timeshare packages, religion, politics, sex, liquor, credit cards and firearms.

The City of Joplin, Joplin Convention and Visitors Bureau, and Joplin Area Chamber of Commerce, agents, volunteers, representatives, or anyone associated with Boomtown Days accept no responsibility for damage, theft, or loss to exhibitors and or their works.

Exhibitors and visitors to Boomtown Days will assume all risk of accident or injury. The City of Joplin, Joplin Convention and Visitors Bureau and Joplin Area Chamber of Commerce or anyone associated with Boomtown Days will not be held responsible.
