CONDITIONS OF THE SHOW

Boomtown Days provides some opportunities for vending, sampling, and product promotion or sales, however, certain items such as literature, beverages, water, filled water bottles and T-shirts are prohibited. In addition, vending, sampling and promotion of certain categories is prohibited, including tobacco, vacation/time share packages, religion, politics, sex, liquor, credit cards or firearms.

The Business Vendor area includes those businesses selling souvenirs and general products that do not fall under Arts & Crafts or Food.

Business Showcase & Interactive Display Area -- This area includes large promotional inflatables, interactive mobile units, science/history displays, public attractions (i.e., Hummer displays, giant John Deere tractor next to a historical John Deere tractor, Krispy Kreme interactive displays, etc.). See specific guidelines and contact information above for COMMERCIAL VENDING, SAMPLING & PRODUCT/SERVICES SALES/PROMOTIONS.

NO Vendor/Exhibitor may reproduce or create customized Boomtown Days merchandise with the name “Boomtown Days” or any likeness of Boomer without written permission from the Boomtown Days Committee.

Vendor/Exhibitor is responsible for obtaining any and all City of Joplin licenses and should be available for inspection at setup. Missouri sales tax licenses and any other fees related to the booth are the sole responsibility of the Vendor/Exhibitor. Contact the City of Joplin Finance Dept. at (417) 624-0820, x. 242 for more information.

The Boomtown Days Committee will evaluate each application and reserves the right to deny space for the display or sale of individual items which are not of suitable quality to be displayed in a family environment.

No items may be made from elephant or whale ivory.

A completed application must be accompanied by a personal or company check or credit card information for the booth fee AND at least two (2) different photos of a grouping of products to be exhibited and one (1) photo of the display booth completely set up.

VENDOR/EXHIBITOR FEES ARE NON-REFUNDABLE.

If Vendor/Exhibitor does not have a tent, 10' x 10' tents are available from Boomtown Days for an additional \$100 each. A formal request must accompany the completed application.

Electricity is provided (110v, 15 amp service only). Vendors/Exhibitors must provide their own extension cord(s). Additional electrical outlets or a dedicated circuit for equipment that needs more power is available for additional fees. A formal request must accompany the completed application. Security, general lighting, and a hospitality area are provided for exhibitors and vendors.

Applicants not accepted will receive a full refund.

Vendor/Exhibitor is responsible for their own tables, backdrops, and any other materials they need to make an attractive booth display. All displays must be neat and clean and maintained throughout the duration of Boomtown Days.

Setup will begin at 10am on Friday, June 6th and must be completed by 3pm the same day, at which time the Boomtown Days Committee will do a final walk-through. Spaces not occupied by 3pm will result in forfeiture of the booth space and all fees. No refund will be granted.

All vehicles and trailers MUST be removed from the booth area immediately after unloading and PRIOR to display setup. Parking will be provided for all vendor/exhibitor vehicles in designated areas.

Vendors/Exhibitors must be present and set up during ALL hours of the event listed above.

Vendors/Exhibitors may not sublet or apportion space to anyone else.

Vendors/Exhibitors shall be liable for delivery, handling, setup and removal of their own displays and materials. Boomtown Days is not responsible for any items left at the site past 10pm on June 3rd.

The Boomtown Days Committee may require the removal of work considered in violation of these conditions and reserves the right to make final interpretation of all conditions.

The City of Joplin, Joplin Convention and Visitors Bureau, and Joplin Area Chamber of Commerce, agents, volunteers, representatives, or anyone associated with Boomtown Days accept no responsibility for damage, theft, or loss to vendors/exhibitors and their works.

Vendors/Exhibitors and visitors to Boomtown Days will assume all risk of accident or injury. The City of Joplin, Joplin Convention and Visitors Bureau and Joplin Area Chamber of Commerce or anyone associated with Boomtown Days/Festival of the Four States will not be held responsible.
